## Soup & Chili Challenge Rules

- 1. In order to participate all Chef's must submit a completed Entry Form by Wednesday, January 9<sup>th</sup>. Entries will not be accepted the day of the Winterfest.*
- 2. Each Chef will receive a number, the number is based on the order the Entry Forms are received. For example, if your Entry Form is the first one received, you will be placed as the first Soup to be tasted by the public.*
- 3. All Chef's must submit a complete list of ingredients with their Entry Form (this list will be placed at your serving site).*
- 4. Chef's must prepare & cook their soup at their residence.*
- 5. All Chef's must provide the following, on the day of ≈*
  - a. Minimum (1) one gallon of pre-cooked, pre-heated soup*
    - i. Please have enough Soup on hand for a large number of Public Voter's*
  - b. (1) Crock Pot to serve from*
  - c. (1) Serving utensil*
  - d. Any other accessories needed*
  - e. 2 oz. cups for serving will be provided*
  - f. Any advertisements/handouts or endorsement for restaurants will not be allowed*
- 6. All chef's must be present and serve their own soup throughout the event.*
- 7. Due to limited space, only one "server" per entry, will be permitted behind the serving table.*
- 8. All entries must be at the Festival Tent by 11:15 a.m.*
- 9. All soup will be served until gone.*
- 10. Judging will be based on a 3 Judge Panel and a separate Public Vote.*
- 11. The Public Vote will end after the first entry is gone.*
- 12. The winner's will be announced at the Festival Tent around 2:00 p.m. Winners will receive a Gift Certificate to the restaurant of their choice located in Grosse Pointe Farms. Chefs are only eligible for 1 Prize.*

## Judging Procedure

*Each entry will receive a number. The 3 Judge Panel will judge 11:30 a.m.-12:00 p.m. and place their votes before public voting begins. Beginning after the Judging Panel makes their decision, tickets will be handed out as the public enters the Challenge area. There will be a can for each entry. The public may put their ticket in the can of the entry that they want to vote for. When the first soup run's out, public votes will be counted.*
